### ON ACTION GRANT TO SUPPORT A HERA LABORATORY NETWORK (EU4H-2021-PJ4)

**Friday 10<sup>th</sup> June 2022, 14.00 – 16:00 CEST, Brussels time**

We invite you to join this webinar.

On 12 April 2022 the Commission amended the 2021 EU4Health work programme, including a specific action to support a European Health Emergency preparedness and Response Authority (HERA) laboratory network.

This action aims to establish a pilot network of top-class laboratories and research institutes that have the critical expertise and capacities to provide the information needed in the shortest possible timeframe and to support HERA in identifying emergent pathogens and ensuring the availability of medical countermeasures for improved health preparedness and response.

The budget available is €25 million. The Health and Digital Executive Agency (HaDEA) will manage the programme. The call was published on 12 May on the [F&T Portal](#).

The information session is organised by HaDEA with the participation of DG HERA and aims at presenting the policy context, objectives and expected impact, as well as the procedure for this action grant.
